The member's per-month tier pricing is based on community, virtual office, shared desk, and dedicated office space options.

“We will be occupying the entire top floor of the building and that will provide a picturesque landscape view of western Massachusetts,” commented Gagne. “A large portion of the office space will be able to enjoy majestic views of seasonal New England.”
